THE SUSPECT DID NOT RETURN THE CHILDREN TO BRIAN MILLER'S DIAMOND BAR RESIDENCE PURSUANT TO A COURT ORDER. CONGRESSMAN MILLER REPRESENTS THE 42ND CONGRESSIONAL DISTRICT OF CALIFORNIA.

WE ARE SEEKING THE PUBLIC'S HELP IN LOCATING THE MOTHER, JENNIFER DEJONGH, FH/29, WHO IS WANTED IN CONNECTION WITH PARENTAL ABDUCTION OF HER THREE CHILDREN, BRIAN MILLER 8-YEAR-OLD, AND 6-YEAR-OLD TWINS EVAN AND CHRISTIAN MILLER. THEY WERE LAST SEEN ON NOVEMBER 18,2007, AT APPROXIMATELY 10:00 AM.
